## 1. Who we are

We are the **data controller** for the personal information collected through this website.

## 2. What information we collect

We collect personal information only when you actively provide it to us. This includes:

- Your email address and first name, when you subscribe to our newsletter
- Your name and email address, when you contact us through the contact form
- Technical data collected automatically by our website platform (Wix.com), including IP address, browser type, and pages visited

We do not collect sensitive personal data or payment information.

## 3. How we collect it

Information is collected through:

- The newsletter subscription form on this website
  - The contact form on this website
  - Automatic technical data collected by Wix.com when you visit the site

## 4. Why we collect it

We use your personal information for the following purposes only:

- To send you our newsletter (film news, screenings, and updates related to *Leurs Regards / Through Their Eyes*), subject to your explicit consent
- To respond to your enquiries submitted via the contact form

- To understand how our website is used, in order to improve it

We will never use your data for commercial purposes unrelated to our film, nor sell or share it with third parties for marketing purposes.

## 5. Legal basis (GDPR)

Under the General Data Protection Regulation (EU 2016/679), we process your data on the following legal bases:

- **Consent** - for newsletter subscriptions (Article 6(1)(a))
  - **Legitimate interest** - for responding to contact form enquiries (Article 6(1)(f))
  - **Legitimate interest** - for basic website analytics (Article 6(1)(f))

## 6. How we store your data

This website is hosted on the Wix.com platform. Wix.com provides the online infrastructure that allows us to operate this website. Your data may be stored on Wix's secure servers within the European Union or in countries providing equivalent data protection safeguards. Wix.com acts as our data processor and operates in compliance with GDPR.

Newsletter data is managed via **Mailchimp** (Intuit Inc.), which processes data in accordance with GDPR through Standard Contractual Clauses.

We retain your email address for as long as you remain subscribed to our newsletter. Contact form data is retained only as long as necessary to respond to your enquiry.

## 7. Cookies

This website uses cookies placed by Wix.com to ensure the basic functioning of the site and to collect anonymised traffic statistics. No advertising or third-party tracking cookies are used by us directly.

You may manage or disable cookies through your browser settings at any time.

## 8. Your rights

Under GDPR, you have the right to:

- Correct inaccurate data
- Request deletion of your data

- Withdraw your consent to receive our newsletter at any time (via the unsubscribe link in every email, or by contacting us directly)
